Open Letter to President Trump

We the undersigned leaders of the 5th District Republican Congressional Committee strongly urge President Donald Trump to reconsider his endorsement of Congressman Bob Good's opponent in the Republican Primary.

Congressman Bob Good has championed America First policies by introducing legislation to codify policies defunding chain migration and requiring that immigrants are self-sufficient. He also offered multiple bills that would build upon Trump's regulatory relief for businesses across the country.

During his time in public office, Bob has demonstrated bold and courageous leadership with his exhaustive offense against the progressive left Democrat agenda. His unimpeachable conservative voting record in Congress earned him a 100% score from Heritage Action for America, Family Research Council, Americans for Prosperity, Conservative Review, and Numbers USA. In 2023, he was elected chairman of the House Freedom Caucus which is holding the line against corrupt politicians on both sides of the aisle.
